 - Cancellation or withdraw after Feb 28, 2020 forfeits 100% of your Total Event Space Charge.
- Downsizing
 - You may downsize your booth with a written request prior to Feb 28, 2020. If approved you will be refunded the difference in booth size.
 - Beginning Mar 1, 2020 no refunds for downsizing are available.
